I/We agree to hold harmless and indemnify Doublehead Realty and Property Management LLC. Doublehead Management, its officers, employees, agents, shareholders, and directors from any and all liability for claims of personal injury or death and for property damage, including all costs, expenses, and attorney's fees incurred in the investigation and defense of such claims, arising out of or relating to the use of watercraft or other recreational facilities by the undersigned or the minor(s)/participant(s) named below. The undersigned acknowledges that this indemnity contract is based on valid and legal consideration. The undersigned represents that he/she has executed this indemnity contract to induce Doublehead Realty and Property Management to allow the undersigned and the minor(s)/participant(s) to rent and/or operate the designated watercraft and/or recreational facilities as specified below. Although Doublehead staff will instruct all persons in the use of Doublehead watercraft and/or recreational facilities, Doublehead and its staff reserves the right to refuse rental of watercraft, golf cart rentals or the use of recreational facilities to anyone for any reason. **ANY PERSON UNDER THE AGE OF 18 (EIGHTEEN) MUST HAVE A PARENT OR LEGAL GUARDIAN SIGN THIS INDEMNITY CONTRACT ON HIS/HER BEHALF. NOTE: EFFECTIVE 9/01/2003, MOTORIZED WATERCRAFT OPERATORS MUST BE 18 (EIGHTEEN) YEARS OLD. ABSOLUTELY NO ONE UNDER 18 IS ALLOWED TO DRIVE OR OPERATE ANY MOTORIZED WATERCRAFT OR GOLF CART. YOUR SIGNATURE BELOW ATTESTS THAT YOU WILL NOT ALLOW ANYONE IN YOUR PARTY UNDER 18 TO DO SO.**

**Watercraft Warning**

The use of watercraft exposes the operator(s) and passenger(s) to various risks, including but not limited to insect bites, sunburn, snake bites, or drowning. A person with allergies that may cause a problem should not ride any watercraft without proper protections. **WATERCRAFT RENTERS WILL BE RESPONSIBLE FOR ANY AND ALL DAMAGES TO DOUBLEHEAD WATERCRAFT EXCEPT FOR MECHANICAL PROBLEMS WHICH MAY OCCUR THROUGH NORMAL USE.**
